
# FOR WHOM THE SANCTIONS CALL



This report contains the materials gathered by NGO CrimeaSOS listing the names of judges with authority in criminal cases or those who have issued verdicts in cases on current victims of political persecution in Crimea. This document contains references to the case numbers and the unique identifiers for each court case.

The goal of this effort is to hold the judges accountable for human rights violations, war crimes and crimes against humanity for improperly sentencing Crimean political prisoners. Justice should be carried out with the assistance of the Ukrainian law enforcement agencies or through the application of the international justice mechanisms (International Criminal Court, mechanisms of universal jurisdiction and international sanctions).

# INTRODUCTION

Since the beginning of the occupation of the Autonomous Republic of Crimea and the city of Sevastopol in 2014, the russian federation extended its jurisdiction to the occupied territories and began politically-motivated persecution of anyone who opposes the occupation or expresses the slightest disagreement with the actions of the occupying authorities. Crimean Tatars, pro-Ukrainian citizens, independent journalists, community activists, various religious groups and others have been persecuted. According to CrimeaSOS, to date, the occupation authorities are conducting politically motivated criminal prosecutions of 140 people.

These politically-motivated prosecutions are conducted with numerous procedural violations, including frequent violations of the right to fair trial. russian authorities have been presenting fraudulent "evidence" and coercing prisoners through torture and degrading conditions of detention. Also, many citizens of Ukraine are forcefully transferred to the russian federation, which violates international humanitarian law, and complicates the access of lawyers and families to political prisoners.

Judges play an important role in the politically-motivated imprisonment of Ukrainian citizens in the occupied Crimea and the russian federation. By delivering a biased verdict "in the name of the russian federation", the judges are directly involved in a number of violations of international law.

Unfortunately, to date very few of the judges involved in these politically-motivated persecutions have been sanctioned or otherwise prosecuted.

It is necessary to identify the russian judges and their Crimean colleagues involved in the aforementioned human rights violations. Additionally, the international community must facilitate accountability with the assistance of the Ukrainian law enforcement agencies or through the application of the international justice mechanisms (International Criminal Court, mechanisms of universal jurisdiction and international sanctions).

# POLITICAL PRISONERS

According to the evidence gathered by CrimeaSOS, as of end of April 2022, 140 people are victims of politically-motivated criminal prosecutions, among them 103 Crimean Tatars. Of those 122 people who are in detention, 97 are Crimean Tatars.

Since 2014, politically motivated persecutions have been directed at the following groups: persons who express disagreement with the occupation, persons who express pro-Ukrainian political views, media, journalists, members of the Crimean Tatar ethnic minority, persons persecuted on religious grounds, and persons advocating the preservation of the Ukrainian language, culture, and identity.

The most frequent charges are related to the alleged association with the 'Hizb ut Tahrir'<sup>1</sup>. Of the 85 people who are currently charged in these types of cases, 81 are currently imprisoned.

14 Jehovah's Witnesses<sup>2</sup> were subjected to politically motivated criminal prosecution on charges of allegedly organizing or participating in extremist activities. Four of them are imprisoned and 10 are under house arrest.

10 people are accused of alleged involvement in the battalion of Noman Chelebidzhikhan<sup>3</sup>.

Eight people were charged with alleged espionage or high treason. Distinction in these types of charges is based on whether a person received a Russian "passport" after the occupation of Crimea in 2014.

Eight people were charged with alleged sabotage.

Today, 14 journalists are victims of politically-motivated persecution on various charges, mostly related to alleged production, storage, and transportation of explosives.

It is important to note that in all of the above cases and other cases of politically-motivated persecution, we use "allegedly" because these prosecutions are often carried out on the basis of planted and falsified evidence, frequent procedural violations and without a fair trial. In a number of cases, confessions were obtained under the circumstances of torture, with

prisoners being subjected to inhuman and degrading treatment. Some political prisoners are subjected to a punitive confinement or forced to undergo involuntary psychiatric examination.

Without the access to due process, proper criminal procedure, suitable conditions of detention, conditions of non-discrimination, as well as other human rights, CrimeaSOS concludes that these criminal prosecutions are carried out solely for political reasons and are without legal basis nor gathered according to proper legal procedures.

The table below provides information on persons subjected to politically motivated persecution, the date of their detention, the charges brought against them, as well as the unique identifier and the criminal case number (except for cases where this determination is not yet possible).

### **JUDGES**

We were able to identify 42 judges involved in 125 politically-motivated criminal persecutions in Crimea. For the remaining 15 persons, either a judge has not yet been assigned the case on the merits, or at the moment we do not have the opportunity to determine the appointed judge.

Of the identified judges: 26 are "judges" on the territory of Crimea, and 18 are judges on the territory of the russian federation. At least 15 of the Crimean judges are collaborators of the invaders: they either betrayed their oath in 2014 in favor of the occupying authorities, or they are citizens of Ukraine who were sworn in as judges of the Russian Federation in Crimea after 2014.

# **CONCLUSIONS**

- 1. 90 of the 140 politicaly persecuted persons have been sentenced.
- 2. 81 people were sentenced to prison time. The sum of their sentences is 1002 years and 2 months.
- 3. Judges who tried the largest number of politically-motivated cases, including where several persons may have been tried in each case:

At the same time, on average, following judges of the Southern District Military Court of Rostov-on-Don sentence political prisoners to the harshest prison terms: **Volkov Oleg Valeryevich** (17.6 years of imprisonment in average), **Gorelov Sergei Mikhailovich** and **Zhydkov Stanislav Vladimirovich** (17 years of imprisonment in average).

### INTERNATIONAL LAW VILATIONS

Below the list of violations of the international law by Russian judges and Russian-controlled Crimean judges as part of politically motivated prosecutions is presented:

#### International humanitarian law violations:

- Extension of the penal laws of the occupying power to the occupied territory (art. 43 of the Hague Statute on the Laws and Customs of War on Land, art. 64 IV of the Geneva Convention);
- In some cases (cases of Euromaidan activists, "February 26 case") retroactive application of the penal provisions enacted by the occupying power (art. 65 IV of the Geneva Convention, art. 75 (4) (c) Additional Protocol I);
- Unlawful deportation or transfer or unlawful confinement of a protected person (art. 147 IV of the Geneva Convention);
- Willfully depriving a protected person of the rights of fair and regular trial (art. 147 IV Geneva Convention, art. 85(4)(e) Additional Protocol I);
- Violation of the principle of penalty shall be proportionate to the offence (art. 67, art. 70 IV of the Geneva Convention);
- Barring of representatives of the Protecting Power (International Committee of the Red Cross) from court proceedings involving a sentence of imprisonment for two years or more (Article 74 IV of the Geneva Convention).

#### International human rights law violations:

- Violation of the right to liberty and security of the person (Article 9 of the International Covenant on Civil and Political Rights, Article 5 of the European Convention on Human Rights);
- Violation of the right to a fair trial (art. 14 (1), art. 14 (3) of the International Covenant on Civil and Political Rights, art. 6 of the European Convention on Human Rights);
- In some cases punishment without law (Article 15 of the International Covenant on Civil and Political Rights, Article 7 of the European Convention on Human Rights);
- In some cases (Jehovah's Witnesses) violation of the right to freedom of religion (Article 18 of the International Covenant on Civil and Political Rights, Article 9 of the European Convention on Human Rights);
- In some cases violation of the right to freedom of expression (Article 19 of the International Covenant on Civil and Political Rights, Article 10 of the European Convention on Human Rights);

• In some cases (cases of 'Hizb ut Tahrir') - Right not to be tried or punished twice in criminal proceedings for the same criminal offence (art. 14 (7) of the International Covenant on Civil and Political Rights, art. 4 of Protocol No. 7 to the European Convention on human rights).

#### War crimes:

- Willfully depriving a civilian of the rights of fair and regular trial (art. 8(2)(a)(vi) of the Rome Statute of the International Criminal Court);
- Unlawful deprivation of liberty (art. 8(2)(a)(vii) of the Rome Statute of the International Criminal Court).

#### Crimes against humanity:

- Imprisonment or other severe deprivation of physical liberty in violation of fundamental rules of international law (art. 7(1)(e) of the Rome Statute of the International Criminal Court);
- Persecution against any identifiable group or collectivity on political, racial, national, ethnic, cultural, religious, gender (art. 7(1)(h) of the Rome Statute of the International Criminal Court).

# RECOMMENDATIONS

#### **National Security and Defense Council of Ukraine**

• Issuance of personal sanctions against judges who convict Crimean political prisoners and other individuals involved in gross human rights violations in occupied Crimea.

#### Verkhovna Rada of Ukraine

• Initiate a bill to amend the sanctions legislation of Ukraine, which would allow the imposition of personal sanctions against citizens of Ukraine who commit war crimes, crimes against humanity and gross violations of human rights.

#### Ministry of Foreign Affairs of Ukraine

• Negotiate with the EU, US, UK, Canada, Switzerland, Japan, Australia and other states regarding the imposition of personal sanctions against judges who convicted Crimean political prisoners, as well as other persons involved in gross human rights violations in the occupied Crimea.

Office of the Prosecutor General of Ukraine, the Prosecutor's Office of the Autonomous Republic of Crimea and the city of Sevastopol, the Main Directorate of the National Police of Ukraine in the Autonomous Republic of Crimea and the city of Sevastopol

- Conduct a thorough and effective investigation of all cases of illegal imprisonment in occupied Crimea;
- Prosecute judges who convict Crimean political prisoners, as well as other individuals who have committed war crimes, crimes against humanity and gross violations of human rights in occupied Crimea;
- Submit to the Office of the Prosecutor of the International Criminal Court the evidence of the criminal conduct by judges and other persons under international crimes statute in the occupied Crimea;
- Under the mechanisms of universal jurisdiction, cooperate with law enforcement agencies of other states to prosecute judges who convict Crimean political prisoners.

#### Office of the Prosecutor of the International Criminal Court

• Continue investigating international crimes in occupied Crimea, including cases of political persecution of various groups and illegal imprisonment.

#### **Foreign States**

- Within the framework of the universal jurisdiction mechanism, prosecute judges who convict Crimean political prisoners, and other individuals involved in gross human rights violations in occupied Crimea;
- Introduce personal sanctions against judges who convict Crimean political prisoners and other individuals involved in gross human rights violations in occupied Crimea.

#### Ukrainian and international human rights organizations

• Continue documenting evidence of political persecution of various groups and of illegal imprisonment.
