



Compelling Crimeans to serve in the russian army is a grave breach of international humanitarian law (Art. 51, Art. 147 of the IV Geneva Convention) and a war crime (Art. 8 (2)(a)(v) of the Rome Statute of the International Criminal Court). States parties shall search for perpetrators of this war crime, shall bring them, regardless of their nationality, before their own courts, and shall afford one another the greatest measure of assistance in connexion with criminal proceedings brought in respect of this war crimes (Art. 146 of the IV Geneva Convention, Art. 88 of the Additional Protocol I to the Geneva Conventions).

*\*Hereinafter all state institutions on the territory of occupied Crimea and their representatives are mentioned with a note that they remain under the control of the russian occupation authorities and therefore are not legitimate from the point of view of the Ukrainian and international law.*
